Deliberation: Dr.Y. Rajasree Rao Principal briefed summary of alumni engagement events and initiatives.

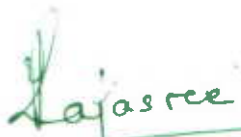
Resolution: Appreciated.
