The Governing Body approved the organization of “Sankranthi Sambaralu” celebrations in the college and sanctioned the necessary arrangements and budget for the event.

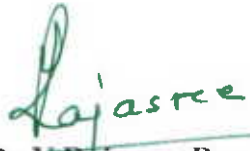
**Conclusion**
